| 8 | Be it enacted by the people of the State of Nebraska, |

Section 1. Section 43-2515, Reissue Revised Statutes of 1 2 Nebraska, is amended to read: 3 43-2515 On or before October 1, 1993, and for each year 4 thereafter, (1) Annually the Department of Health and Human Services 5 and the State Department of Education shall jointly certify to the budget administrator of the budget division of the Department of 6 7 Administrative Services the amount of federal medicaid funds paid to 8 school districts and educational service units pursuant to the Early 9 Intervention Act for special education services for children five 10 years of age and older. The General Fund appropriation to the State 11 Department of Education for state special education aid shall be 12 decreased by an amount equal to the amount that would have been 13 reimbursed with state general funds to the school districts through the special education reimbursement process for special education 14 15 services for children five years of age and older that was paid to 16 school districts or approved cooperatives with federal medicaid funds. It is the intent of the Legislature that an amount equal to 17 18 the amount that would have been reimbursed with state general funds 19 to the school districts, certified to the budget administrator, but 20 not more than three million dollars, be appropriated from the General 21 Fund to aid in carrying out the provisions of the Early Intervention 22 Act and other related early intervention services. 23 (2) Any amount certified to the budget administrator 24 pursuant to subsection (1) of this section in excess of three million

dollars shall be remitted by the Department of Health and Human

- 79-1018.01 Except as otherwise provided in this section,
- 24 local system formula resources include other actual receipts
- 25 available for the funding of general fund operating expenditures as

- 2 immediately preceding the school fiscal year in which aid is to be
- 3 paid. Other actual receipts include:
